SUB: Guidelines for conducting Online examination for Persons With Disabilities (PWD) candidates for Direct Recruitment of Junior Engineer (erstwhile TTA) in BSNL – reg.

Please refer to this Office letter No. 7-1/2016-Rectt. dated 24/06/2016, vide which Revised Notification has been issued for conducting Online examination for Direct Recruitment of Junior Engineer (erstwhile TTA) in BSNL from Open Market. The aforesaid Online examination is scheduled to start from 25/09/2016.

In this regard, all Circles are instructed to follow the Guidelines issued by Govt. of India, Ministry of Social Justice & Empowerment, Department of Disability Affairs vide their O.M. No. 16-110/2003-DD.III dated 26/02/2016, for conducting written examination for Persons With Disabilities (PWD) (Copy enclosed).

Further, it has been decided that the facility of Scribe is to be allowed to the candidates, whose writing speed is adversely affected due to Locomotor Disability and Cerebral Palsy, if so desired by the candidate.

Such PWD candidates, who have opted for the Examination Centre in the respective Telecom Circle, are required to furnish the duly filled Scribe Declaration Form along with the photograph of the proposed Scribe as well as copy of the Medical Certificate to the concerned Telecom Circle at least 10 days before the scheduled date of Online examination for Direct Recruitment of Junior Engineers (erstwhile TTA). (Copy of the Scribe Declaration Form is enclosed herewith). The Circles are required to scrutinize the Scribe Declaration Forms received from the candidates and after consolidating the list of candidates eligible for availing the facility of Scribe, the Heads of Circles are required to furnish the complete list of eligible PWD candidates opting for the assistance of Scribe in their Circle to Recruitment Branch of BSNL Corporate Office before 7 days of the Online Examination date, so that necessary arrangements could be made for such candidates.

Accordingly, all Heads of Circles are requested to give necessary instructions to the Examination Coordinators in their respective Circles to follow the aforesaid Guidelines. The Examination Coordinators are required to keep strict vigil during the Online examination process to prevent any kind of cheating/malpractice etc. by the candidates, who have opted for the assistance of Scribe.
